IN-DOOR-P-RAN9004

Front Removal: Remove components shown from both sides of machine.

- keep all components removed from machine -

Front Doors must be installed first!

Front Doors Installation: Do not tighten hardware completely unless noted.


Secure Front Driver Door (B) to Roll Cage with stock hardware.




Secure Front Driver Door (B) to Floor with M6-1.0 x 30mm Lg. Bolts.



(Driver Side shown)




- Install Front Striker Bracket (Driver) (F) with hardware shown.



IN-DOOR-P-RAN9004

- Place Rear Upper Fender on machine and mark area around Front Striker Bracket (Driver) (F) that will need trimmed.
- Remove, trim, and install hardware shown to Front Striker Bracket (Driver) (F).





- Close Front Driver Door (B) completely so that Latch engages.
- Align to machine and tighten all hardware completely.



- Reinstall Upper Rear Upper Fender with stock hardware.
- Repeat steps for opposite side.

Rear Removal: Remove components shown from both sides of machine.








Rear Doors Installation: Do not tighten hardware completely unless noted.

- Secure Rear Driver Door (E) with stock hardware.




- Secure Rear Driver Door (E) to Floor with M6-1.0 x 30mm Lg. Bolts.



- Close Rear Driver Door (E) completely so that Latch engages.
- Align to machine and tighten all hardware completely.

- Repeat steps for opposite side.
